To Whom It May Concern:

In the fall of 2007, Temple Israel contracted with Riley Palmer Construction Company, Inc. to act as general contractor for a major renovation we were undertaking.

As a place of worship for 400 Tallahassee families, we were concerned about the sanctity of our space. As a preschool center for 150 two to five year-olds, we were also concerned about the security of our children. During the renovation, we needed to be able to use the areas of our building not under construction and also had a strict deadline as to when the renovations needed to be completed.


From the first meetings with Mr. Palmer and Mr. Webb (project manager) our concerns were met with respect and understanding. All aspects of our project – from demolition through completion – were handled with the utmost professionalism. We were most appreciative of the fact that all sub-contractors chosen by RPCC were also expected to perform to the standards set by Temple Israel.

When we were able to move into our renovated space, it was on time and under budget.
